1. The Annual General Meeting of the General Body shall be held once a year at the call of the President of the Managing Committee preferably in the month of December, the notice of which shall be served by the General Secretary of the Managing Committee at least fifteen days in advance. 2. The President of the Managing Committee may call an Extra Ordinary General Meeting of the General Body, following a decision of the Managing Committee to this effect. The notice of such EGM shall be served by the General Secretary of the Managing Committee at least seven days in advance. 3. The AGM shall, among others, a. Discuss and approve Annual Report of the Society, b. Consider and approve, as deemed fit, the Auditor's Report containing audited accounts of the Managing Committee and the Account of Society, c. Discuss and resolve matters for which a notice has been received from a member of the General Body, as least seven days prior to the date of meeting, subject to the permission of the chair of the AGM. 4. The President of the Managing Committee shall preside over all the meetings of the General Body. In the absence of the President, the Vice President shall preside over the meetings. In the absence of Vice President, any member of Managing Committee as decided by the Committee shall preside over the meeting.

The Managing Committee shall be responsible for maintaining contacts with the alumni, carrying out drive for Memberships, planning and organizing programs and projects including organizing seminars, symposia, workshops and lectures, and solicitation and collection of funds and resources for the Society. 2. The Managing Committee may formulate development projects and programs in line with the objectives and purposes of the Society. 3. Each year, the Managing Committee shall prepare the Annual Report of the Society and get the accounts of the Managing Committee audited by a Chartered Accountant. The Annual Report and the Auditor Report shall be placed in the Annual General Meeting AGM of the Society for consideration and approval.

Election Procedure of Management Committee by
General Body :

1. The first managing committee of the GNIOT Alumni Association Society has been constituted in order to begin the activities of society with the consent of all general body members. They have appointed a president, a vice president, a joint secretary, a treasurer, three members, and a general secretary. 2. The First Managing Committee shall carry out the activities of the Society until the first election of the Managing Committee, which must be held within three years from the formation of the First Managing Committee. 3. The election of the Managing Committee of the Society shall be held in the month of December every three years. 4. The Managing Committee shall appoint an Election Commission, consisting of one Chief Election Commissioner and two Election Commissioners, from among the members of the General Body of the Alumni Association, who will not be candidates for any position of the Managing Committee in that particular year. 5. The Election Commission shall carry out all activities necessary for successful holding of the election and the Managing Committee shall provide all necessary support and assistance to this effect. 6. The election shall be held by secret ballot through reliable and secured physical or electronic means. Details of the election procedure shall be formulated by the Election Commission, within the framework of the Memorandum and the Bye Laws of the Society. 7. Notice containing detailed procedures and necessary documents, e.g., nomination papers shall be issued by the Election Commission at least thirty days before the scheduled Election Day. 8. After receiving the nomination papers for the posts of President, Vice President, General Secretary, Treasurer, and Two Members, the Election Commission shall scrutinize the nomination papers and display the list of valid candidates on notice Board at the office of Society as well as on the webpage of the GNIOT Alumni Association Society. A candidate who wishes to withdraw candidature shall do so, in writing, within forty eight hours of the publication of the list of valid candidates. 9. The Election Commission shall prepare a final list of all valid candidates within one working day after the time for withdrawal of candidature is over and will make available short bio data of the candidates to the General Body. 10. Personal campaign of any sort shall not be allowed and the Election Commission can take any punitive measure as deemed fit, including disqualification of candidature, if any candidate is found to violate this rule. 11. The Chief Election Commissioner shall announce the election results.
